Pet Care Authorization and Release Form:

*Initials*____ Dog Diggity Daycare & Boarding LLC (DDD) will keep the premises sanitary and properly enclosed and exercise reasonable care for the safety of your dog. All dogs will be housed in safe, clean quarters. All dogs will be fed properly and regularly. DDD cannot be liable for damage or loss by or to dogs nor their belongings at this facility.

*Initials*____ Owner understands the concept of dog daycare, group play, and overnight boarding is to allow dogs to socially interact with both humans and dogs. Dogs in our facility participate in supervised activities such as running, jumping, playing; there is always a possibility of injury resulting from rough play between dogs. The owner agrees that any injury to their dog during their use of the facility shall not bring any liability of any type on the part of DDD.

*Initials*____ Owner agrees not to bring their pet into our facility if the dog is showing any signs of being sick, has fleas (owner will be charged for flea bath), worms, has any open or healing wound, or that its behavior may jeopardize the safety and health of other pets and/or our staff.

*Initials*____ Abandonment shall automatically relinquish all rights and claims by the owner to the animal. Abandonment is determined to be the refusal to provide or perform the legal obligations for care of the animal by its owner or agent.

*Initials*____ DDD is authorized by the owner to seek veterinary care, including emergency care, at the owner's expense. If time permits, DDD will try and contact you before obtaining any care; however, this form serves as the authorization DDD needs to obtain veterinarian care for your dog regardless. The owner is responsible for veterinarian expenses and transportation, whether or not the owner was reached in advance.

*Initials*____ The owner agrees to pay all charges for daycare and boarding before picking up their pet. Your pet will not be released until all charges are paid in full. Boarding check out time is 12:00 pm. Dogs picked up after 12:00 pm will be charged \$12.00 (per dog) for additional daycare services. All daycare dogs must be picked up by the end of the business day. If not picked up by closing time, the dog will be placed in our boarding facility and the owner will be charged \$43.00 for a night of boarding and will not be available to pick up until the next business day. Late pick-ups will be charged a night of boarding.

*Initials*____ Dogs must be spayed or neutered.

*Initials*____ Prices are subject to change without notice.

*Initials*____ The owner covenants not to initiate any legal proceedings of any sort against DDD as a result of illness, injury, damage or death to owner's dog while staying at DDD and agree that, should the owner bring a legal action against DDD, the correct result of such a legal action should be a summary dismissal in favor of DDD and the owner will also agree to pay DDD costs, including, but not limited to attorney's fees.

Pet Care Authorization and Release Form:

*Initials*____ The owner agrees that by signing the Care and Authorization form one time that it remains in full effect and force each and every time the owner brings the owner's dog or dogs to DDD for any of our services. This includes any and all owner's dogs and any future dogs.

*Initials*____ Naptime hours are always included during time of daycare and are accounted for in the total price.

*Initials*____ Owner is responsible for providing a collar or harness with a name tag. Failure to do so will result in additional charges.

*Initials*____ Please cancel bookings as soon as possible. Cancellations and No-Shows that take place less than 48 hours of the scheduled date will then forfeit any deposit. Cancelled and No-Show holiday bookings are non-refundable and will be charged the entire scheduled cancelled or no-show visit. All reservations for boarding must be made 24 hours in advance.

*Initials*____ Daycare passes are non-refundable, expire 6 months after purchase, and cannot be used for boarding.

*Initials*____ Owner is aware of their dog's breed specific health issues that may hinder their ability to participate in play time safely including, but not limited to, brachycephalic breeds.

*Initials*____ DDD is not responsible for dogs that jump the fence and dogs that get loose from the owner and run away.

*Initials*____ Daycare Pass Packages are based upon a discounted full day rate. Customers may use one pass per visit regardless of time spent in our facility on that given day. Passes may not be split.

I HAVE READ, UNDERSTAND, AND AGREE TO ALL THE PROVISIONS OF THIS AUTHORIZATION. I fully intend to pick up my dog on the specified date. I will notify Dog Diggity Daycare of any changes to the pick-up date and assume full responsibility for any additional charges.

The owner hereby agrees to waive and release DDD and their employees from any right that you may have in law to recover medical payments, bodily injury damages, or property damages for any liability regardless of the cost, as a result of any injury resulting from the actions of my dog, any other dog, or any humans.

I hereby agree to the pet care authorization form as the owner of the dog (s). I also certify that my dog(s) is/are in good health and do not show any signs of illness that may be contagious. Furthermore, I certify that all the information provided about my dog is accurate to the best of my knowledge. I have read, understand, and agree to all the provisions of this form.
